1.0 BACKGROUND

Society of St. Vincent de Paul (SSVP) is a worldwide movement fulfilling uniquely one of the principal apostolates of the church. It was founded in France by Blessed Frederick Ozanam in 1833 and extended to Nigeria in 1960.

The Society seeks before everything else the personal sanctification of its members, which bears fruit in acts of justice and charity towards the poor.

2.0 AIMS AND OBJECTIVES

The aims and objectives of the Council lies squarely on charity to the needy; to seek and find those who are forgotten or neglected; to bring Christ's love to those suffering or deprived and comfort those troubled or in distress; to provide food, shelter and clothing to those in need; to render medical assistance to those who are sick; bring succor to those who are in prison and assist in the spiritual growth of those we serve.

3.0 SCHEDULE OF MEETING

The Council holds her meetings quarterly and usually on the 2nd Saturday of the month in a particular quarter slated for the meeting. The meeting rotates round all Conferences within the Council to allow for greater and active participation of Conferences and promote cordial relationship between the Council and Conferences as well as fraternity among members.

4.0 MEMBERSHIP

5.0 GROWTH

During the period under review, the Council secured the appointment of Rev. Fr.

Sebastian Musa, by the Archbishop, as the Spiritual Director of the Council.

The Council also inaugurated 4 conferences namely:

- St John de Beloved Conference Tungan Maaji on 7th June, 2015
- Sacred Heart Conference Airport.
- St. Christopher Conference Games Village on 9th August, 2015
- C.K.C Conference Kurudu on 19th Day of July, 2015

6.0 MAJOR PROJECTS

The Councils Ozanam House project is still on course. Council is looking at every means to overcome the challenges being faced in the project. Presently the Council is weighing a lot of options on the next line of action among which is securing alternative land or embarking on the building of bridge across the valley for access to the site.

7.0 PROGRAMMES FOR THE YEAR:

The Council as usual continues carrying out its primary duties and activities by coordinating and supervising the activities and performances of Conferences. During the year under review, many centers had been established and brought into the Council. Some conferences that were inactive were reactivated through visits, discussions; awareness campaign and membership drive in the respective conferences.

Food sharing during the Easter and Christmas periods was organized to happen simultaneously across all conferences on the same day and at the same time.

Other activities of the Council within the year under review include:

- Hosting the Joint feast celebration of the Vincentian family. All the various arms of the family were present at Our Lady Queen of Nigeria Pro cathedral for the event.
- Hosting of the Metro Council meeting on the 7th day of February, 2015 at DRAAC, Sabon Lugbe Abuja
- Charity Walk and Hospital Visitation by the Society of St. Vincent de Paul, Abuja Central Council on 19th September, 2015

• Visit to Internally Displaced Peoples Camp (IDP) Camp March 5, 2015. Food items, clothes, water, mats etc were distributed during the visit.

8.0 MAJOR CHALLENGES:

One of the greatest challenges being face by Abuja Central Council is the development of the Ozanam House. Council is looking for ways and means to sort out the challenge of access to the site and equally raising fund to kick start the project.

9.0 INSTITUTION, AGGREGATION AND TWINNING

Abuja Central Council was instituted on 3rd July, 2001. In pursuit of meeting with the stipulated criteria and operating strictly in consonance with the set objectives of the Society, Conferences had been encouraged to fill and submit aggregation forms and submit to the Council for further transmission to International head office. However, twenty four (24) conferences in the Council had been aggregated.

The Council has been making serious efforts in training conferences to understand the meaning, modalities and benefits of twinning. It is hoped that very soon, Conferences will take advantage of it.

10.0 WAYS OF COOPERATION

There is the need for greater cooperation between the Conferences and the Council. This was achieved though rotational meetings of the Council between the Conferences and regular visits of the Council to the Conferences. Since all Conferences are working towards achieving the same goals of the Society, many conferences with more resources had been of great support to those with less resources to enable them take care of the needy in their environments.

11.0 WAYS HIGHER COUNCIL CAN ASSIST LOWER COUNCIL

While lower Councils perform their financial obligations to higher Council, higher Council should in turn give moral support to the lower councils; advising them in the face of challenges and open up constant channel of communications for smooth flow of information.
