# 1.0 BACKGROUND

Society of St. Vincent de Paul (SSVP) is a worldwide movement fulfilling uniquely one of the principal apostolates of the church. It was founded in France by Blessed Frederick Ozanam in 1833 and extended to Nigeria in 1960.

The Society seeks before everything else the personal sanctification of its members, which bears fruit in acts of justice and charity towards the poor.

# 2.0 AIMS AND OBJECTIVES

The aims and objectives of the Council lies squarely on charity to the needy; to seek and find those who are forgotten or neglected; to bring Christ's love to those suffering or deprived and comfort those troubled or in distress; to provide food, shelter and clothing to those in need; to render medical assistance to those who are sick; bring succor to those who are in prison and assist in the spiritual growth of those we serve.

# 3.0 SCHEDULE OF MEETING

The Council holds her meetings quarterly and usually on the 2<sup>nd</sup> Saturday of the month in a particular quarter slated for the meeting. The meeting rotates round all Conferences within the Council to allow for greater and active participation of Conferences and promote cordial relationship between the Council and Conferences as well as fraternity among members.

#### **6.0 MAJOR PROJECTS**

The Councils Ozanam House project is still on course. Council is looking at every means to overcome the challenges being faced in the project. Presently the Council is trying as much as possible o shore up the project account to a meaningful level that will enable a tangible activity on the site. Building a bridge across the valley for access to the site is also being considered.

#### 7.0 PROGRAMMES FOR THE YEAR:

The Council as usual continued carrying out its primary duties and activities by coordinating and supervising the activities and performances of Conferences. During the year under review, many conferences under tutelage were inaugurated and brought into the Council.

Some conferences that were inactive were reactivated through visits and discussions, awareness campaign and membership drive in the respective conferences. Food sharing during the Easter and Christmas periods was organized to happen simultaneously across all conferences on the same day and at the same time.

During the course of the year, the Central Council carried out and also participated in lots of activities as detailed hereunder:

# 7.1 Participation of the Central Council in SSVP Activities:

- The Joint feast celebration of the Vincentian family: All the various arms of the family were present at SS Simon & Jude Minor Seminary, Kuje on 23<sup>rd</sup> October 2016. A committee to plan the 400<sup>th</sup> anniversary celebration of St. Vincent de Paul was constituted. The committee which is made up of members drawn from the various arms of the family is headed by Sir. Patrick Ebhojie, the National Patron and International Territorial Vice President for Africa 1
- Hosting of the National Council Annual General Meeting(AGM) from 29<sup>th</sup> April to 1<sup>st</sup> May, 2016 at DRAAC, Sabon Lugbe, Abuja.
- The Metro Council meeting held at Lokoja on 12<sup>th</sup> -14<sup>th</sup> March, 2016.
- The 44<sup>th</sup> meeting of Abuja Metropolitan Council which took place on 12<sup>th</sup> 14<sup>th</sup> August, 2016 at Lafia.

Collaboration with the Leprosy Foundation of Nigeria: The Council collaborated with the
foundation in disseminating information concerning the disease and enlightening the public on
the misconceptions attached to the disease. This was achieved through marketing a home
video which encapsulated in a DVD format the information and message being passed in a
movie.

# 7.2 Activities Organized by the Central Council:

# 1. Training:

The Abuja Central Council of the Society of St. Vincent de Paul, Nigeria in its bid to equip members with the wherewithal to face challenges encountered in the course of carrying out its duties to their masters (the poor and the needy) and also to understand the rules and regulations of the Society in order to take the Society to greater heights organizes training for its member's bi annually.

# A. First Training of the Year

The first training for the year held as scheduled at Christ the King Church Conference Kubwa on the 14<sup>th</sup> of May, 2016.

The training topics include:

- ii. Twinning Procedures: Presented by Bro. Emma Nnaemeka (Council's Twinning and Aggregation Officer)

# **B.** Second Training of the Year:

The 2<sup>nd</sup> biannual training for the year held as scheduled on the 22<sup>nd</sup> October, 2016 at Holy Trinity Catholic Church, Maitama

The Council introduced a Uniform Account Record Book for Conferences which will require officers of the conferences especially Secretaries, Financial Secretaries and Treasurers to keep their records in such a way that reports can be compiled when required, weekly, monthly, quarterly and annually both for Society's own purposes and for the general public.

It will also afford the Central Council the opportunity not only to maintain uniformity in record keeping without deviating from the format generally used by the International Confederation of the Society of St. Vincent de Paul but also to maintain strict accountability in the management of funds in the Council.

The training centered largely on the proper book keeping and effective utilization of Uniform Account Record Booklet.

#### 2. Youth Activities:

# A. Participation in SSVP Activities:

The youth wing of the Council also participated in various activities being organized both at Metro and National levels. Some of these activities include:

- i. The National youth rally with the theme "Vincentian Apostolate and the Year of Mercy" held on the 25<sup>th</sup> through 28<sup>th</sup> August, 2016 at St. Louis Girls College, Jos.
- ii. The National Youth Coordinators workshop with the theme: "Combating Poverty: The Role of Vincentian Youths" held on the 24<sup>th</sup> through 26<sup>th</sup> of June, 2016 at St. Peters Catholic Church, Ediba Calabar, Cross River State.
- iii. The 7<sup>th</sup> Abuja Metropolitan Youth Rally held at Redeemer Secondary School, Ankpa, Kogi State

# B. Central Council Youth Training:

The Youth of the Council also organized a training on the 12<sup>th</sup> July, 2016 at Our Lady Queen of Nigeria Pro Cathedral Garki.

# C. Youth Visitation to Shenegu Community:

The youth also embarked on a visit to Shenegu community, a remote area in the suburb of Abuja taking food, clothes and other items to them.

# **8.0 MAJOR CHALLENGES:**

One of the greatest challenges being faced by Abuja Central Council is the development of the Ozanam House. Council is looking for ways and means to sort out the challenge of access to the site and equally raising fund to kick start the project.

Furthermore, the need to maintain accurate record keeping by conferences is a challenge the Council has decided to tackle headlong. Council believes that maintaining good and accurate book keeping will uplift the image of the Society and as well build the confidence of the benefactors, priests and lay faithful on the Society, who contribute financially to the work of the Society in catering for the poor and needy.

# 9.0 INSTITUTION, AGGREGATION AND TWINNING

Abuja Central Council was instituted on 3<sup>rd</sup> July, 2001. In pursuit of meeting with the stipulated criteria and operating strictly in consonance with the set objectives of the Society, Conferences had been encouraged to fill and submit aggregation forms to the Council for further transmission to International head office. However, twenty-five (25) conferences in the Council had been aggregated while twenty conferences (20) have applied for aggregation and awaiting their certificates.

The Council has been making serious efforts in training conferences to understand the meaning, modalities and benefits of twinning. It is hoped that very soon, Conferences will take advantage of it.

In furtherance of the above, the Council in its bid to improve the knowledge of conferences on the twinning procedures introduced internal twinning programme within the Council. In this internal arrangement, conferences are twinned to each other for cross fertilization of ideas, financial assistance and mutual collaboration in resource sharing.

#### **10.0 WAYS OF COOPERATION**

There is the need for greater cooperation between the Conferences and the Council. This was achieved though rotational meetings of the Council between the Conferences and regular visits of the Council to the Conferences. Since all Conferences are working towards achieving the same goals of the Society, many conferences with more resources had been of great support to those with less resources to enable them take care of the needy in their environments.

#### 11.0 WAYS HIGHER COUNCIL CAN ASSIST LOWER COUNCIL

While lower Councils perform their financial obligations to higher Council, higher Council should in turn give moral support to the lower councils; advising them in the face of challenges and open up constant channel of communications for smooth flow of information.
