

MINUTES OF THE MEETING OF SOCIETY OF ST. VINCENT DE PAUL (SSVP) NIGERIA, ABUJA CENTRAL COUNCIL HELD ON 31ST JANUARY, 2015 AT ST MARY'S PARISH, KARU, ABUJA.

1.0 ATTENDANCE:

A total of 127 Vincentians were in attendance at the meeting. Details are as shown on pages 8, 9 and 10.

1.1 APOLOGY:

2.0 OPENING:

The meeting started with an opening prayer said by Sis. Joy Ohiagu at 11.00am

3.0 SPIRITUAL READING:

The reading was read by Sis. Okeze Maureen of St. Donald's Conference Karu was taken from page 42 of the manual of the Society. The theme of the reading is "What will people say". Reflecting on the reading, she enjoined Vincentians not to refrain from carrying out good actions because of what people will say and they should equally focus on what God wants about a particular situation.

4.0 OPENING REMARKS BY THE OUTGOING COUNCIL PRESIDENT:

Sis. Joy Ohiagu, on behalf of the outgoing Central Council President, Bro. Paschal Ahizih who was not presently present, welcomed all Vincentians that came from far and near. She equally enjoined all to participate actively.

5.0 WELCOME ADDRESS BY THE HOST PRESIDENT:

The host conference president, Bro. Chuks Okonkwo welcomed all present and prayed for the grace for fruitful deliberations and strength to perform more actions in the course of serving the poor through the Society of St. Vincent de Paul.

6.0 READING, OBSERVATION, AMENDMENT AND ADOPTION OF MINUTES:

The minutes of the previous meeting held at St. John Paul parish, Kubwa on 13th December, 2014 were read by the secretary and the following observations and corrections were made:

- i. Section 8.6: Sacred Heart Airport **“Centre”** and not Sacred Heart Airport **“Conference”**
- ii. Section 9.1: Emmanuel **“Chukwuorji”** not Emmanuel **“Chukwuma”**
- iii. Section 9.6: Sacred **“Heart”** not Sacred **“Heat”**
- iv. Section 9.9: Maureen **“Okeze”** not Maureen **“Okere”**
- v. Section 9.9 Lines 1 and 2: A tentative date in March was earmarked for inauguration, no date yet fixed. The exact date will be agreed upon in the next meeting of the Council.
- vi. Attendance List No. 9: Uja Damaris **“N”** not Uja Damaris **“W”**

In the absence of further corrections and observations, a motion for the adoption of the minutes was moved by Chika Mmuobuikwe of Holy Cross Conference, Gwarimpa and seconded by Jude Akubuo of Holy Family Conference, Life Camp.

7.0 MATTERS ARISING:

7.1 Progress Report on the Inauguration of Sacred Heart Center, Airport:

The coordinator of the center informed the Council that they are performing well and that the challenge they are having now is getting the center inaugurated. They went to the Parish Priest to inform him of their plans for inauguration and to pick a date. He insisted that they have been inaugurated at the church after the elections and there will be no need for another inauguration. Efforts made to educate him on the rules of the society did not yield fruits.

After much deliberation, the Council decided that a delegation will visit the priest with a view to engaging him on the stipulations of our manual and possibly resolving the matter.

7.2 Update on St. Francis Centre, Galadimawa; an Outstation of St. Linus Conference Chika:

Jonathan Maiyaki, president of St. Linus conference, informed the Council that he was unable to meet with the coordinator of St. Francis Centre, Galadimawa; Mr. Solomon Alegbe, as instructed by the former Central Council president. He informed the Council that the case of the outstation centered on the misuse of funds and the said coordinator has been expelled after a meeting with the conference board and the parish priest. He equally tendered a copy of the expulsion letter.

The former president of central council, in his reaction, said that the problem of the Centre is of high magnitude and he blamed the conference president overseeing the Centre for not acting on time. The Council however resolved that the council board should look into the case with a view of finding a lasting solution.

7.3 Remarks by the Parish Priest of St. Mary's Catholic Church:

The Parish Priest, Rev. Fr. Paul Oforha, in his remarks, sincerely welcomed the Council to his parish and thanked the Council for the support they give to the conference. He equally said that the work of the society is indispensable and thanked the society for the various actions in the parish and the archdiocese. Before offering prayer and giving his blessing to the Council, the former president also thanked the Parish Priest for the support he has been given to the conference.

7.4 Feast Day Report:

The chairman of the feast/award day celebration, Sir Patrick Ebhojie, informed the Council that the celebration whose main objective was to bring all Vincentians in the Council together as a family to celebrate the patron saint and also to recognize those who contributed immensely to the service of the poor was remarkable and successful. He narrated the various challenges faced by the committee such as sourcing for adverts and soliciting for funds; screening of the various nominees for the award using very transparent criteria for the process, etc. He equally stressed that the categorization of the conferences was adopted from template used by the archdiocese. They generated an income of N2, 051,600 and expended N1, 978,600 leaving cash balance of N73, 000.00 after the event.

The report also contains the list of the conferences and centers that are yet to pay their levy. He urged them to pay up to enable the Central Council attend to some other issues and also offset the N200,000.00 debt owed Holy Trinity Conference, Maitama.

He advised all to go through the report which is very detailed and avail themselves of some information on the feast day planning and execution. He finally appreciated the immediate past president for conceiving this beautiful idea.

7.5 Update on St. Paul's Conference Gwagwalada by Sir. E.O. Ajewole:

He reported that they paid a visit to the conference, which the report was given in the last Council meeting. However, since some of the board members are present, they should speak. In his response, the vice president of the conference, Ignatius I., appreciated the Council for the high powered delegate sent to resolve issues in their conference. His further response elicited heated reactions from members which exposed the fact that there are some fundamental problems that needed to be resolved for the conference to move forward. The conference

board members present were told to wait behind after the meeting for further discussions with the Council board.

7.6 Update on St. Raphael, Garki II:

The acting president in her response said that they have been meeting but the membership is dwindling. The problem of the church affected them so much that they cannot meet up to their financial obligations. She pleaded with the Council to pay them a visit and help in creating awareness. Reacting to the response, Bro. John Okoro from OLQN informed the house of the unseriousness of the leader whom he said comes late to meetings and sometimes is absent. The acting president was then instructed to listen to those guiding them in order to make progress.

7.7 Metro Meeting Hosting by Sis. Joy Ohiagwu:

She informed the Council that the committee has been meeting and arrangements are in top gear to make sure that the hosting is successful. The meeting is slated to hold at DRACC Sabon Lugbe from 6th to 8th of February, 2015. They have budgeted N750, 000.00 for the hosting and conferences have been levied based on their categories. Grade A = N30, 000.00; Grade B = N20,000.00; Grade C = N10,000.00. Each conference has to sponsor at least 2 members to the meeting at the registration cost of N1500 each on Saturday by 9.00am. Conferences were enjoined to make their money available for the committee on or before Wednesday, 4th February, 2015.

7.9 The Vincentian Family meeting:

The Vincentian family meeting will be coming up on 6th to 8th March, 2015 at DRACC Sabon Lugbe. Five slots are available for the Central Council of the archdiocese. Cost of participation N10, 000.00. Conferences that are willing to sponsor a member should indicate and pay up on time.

N.B: The **Vincentian Family** comprises organizations inspired by the life and work of St. Vincent de Paul. In Nigeria today, we have the following as the existing members of the Vincentian Family: The International Association of Charity (AIC), The Congregation of the Mission (popularly known in Nigeria as the Vincentian Fathers and Brothers), The Daughters of Charity, St. Vincent de Paul Society International, Vincentian Marian Youth and the Association of the Miraculous Medal.

7.10 Handing over to the newly elected Council President:

The outgoing president, Bro. Paschal Ahizih, informed the Council that he has not prepared his handover because he is still awaiting reports from conferences to

enable him galvanize the final report on the finances. The change in the signatories to the Councils bank account will be effected very soon. He pleaded for the understanding of the Council for the formal handover to be conducted at a later date. He however called upon the newly elected president, Bro. Chibuzor Ezeani to take over the proceedings.

7.11 Remarks by the new president of the Council:

In his acceptance remarks, Bro. Chibuzor Ezeani commended the previous executive for their commitment in the way they piloted the affairs of the Society and thanked them for a job well done. He equally thanked the Council members for finding him worthy to be the president. He sought for the support of members to move the society forward and to the next level. Some of his cardinal objectives include:

- i. Repositioning of the Society to make it more corporate using the NGO platform already registered since 2005.
- ii. Expand the programmes of the society
- iii. Projecting the society to be at par with other international charity organizations.

He equally presented to the Council the newly appointed board members and their portfolios for ratification. These are:

8.1 Inauguration of C.K.C Kurudu Centre:

The coordinator, Bro. Emmanuel Ebi reported that there is need to confirm if the inauguration earlier scheduled will still hold.
